## **EARTH & ECOBRICK MANDALA PARK**

### **Hand Over Agreement & Terms of Transfer**

The following document lays out the agreement between the Global Ecobrick Alliance (GEA) and the Probolingo Local Government (PLGU) on the construction, enhancement, maintenance, repair and destruction of the Jampung Mandala Ecobrick Earth Park (JMEEP). In exchange for the services of the GEA to coordinate and build the JMEEP, the PLGU agrees to take full responsibility for the construction and the ecobricks therein according to the tenets of this document.

#### IMPORTANT CAUTION

Ecobricks contain and secure plastic. Ecobricks are being used in this construction as building block and as means to sequester the ecobrick and its contained plastic from all forms of degradation as a community ecological service. Should the JMEEP be destroyed by nature or by intention the ecobricks risk rupture and the escaped plastic risks contaminating the local biosphere. Should the JMEEP be subject to intense heat or fire, the plastic risks combustion and the release of toxic gases and CO<sub>2</sub>.

#### COMMITMENT

*The creation of the JMEEP is a community and ecological service being undertaken by the GEA and PLGU. Both the GEA and the PLGU commit to doing all in their power to keep the ecobricks and plastic safe.*

#### 1. Construction

The GEA will provide a design concept for review and approval by the PLGU. The PLGU will provide a space and parameters for the construction of the JMEEP. Once design and space are agreed to, the GEA agrees to use this space, follow the parameters, and afterwards clean and reconstitute the area of construction. The GEA will fully complete the construction as proposed in initial consultations.

#### 2. Exchange

The GEA will hand over the construction, the ecobricks therein, and the responsibility for the space to the PLGU. The PLGU will then assume full responsibility for the enhancement of the space, the maintenance, the repair and the destruction.

Once completed and handed over by the GEA, the PLGU will enhance the JMEEP with grass, plant the center with a tree and landscape the area appropriately. The GEA will provide guidance on the planting and gardening of the space.

4. Maintenance

The JMEEP will require gardening and aesthetic maintenance. The PLGU takes full responsibility of the space and will check on its status monthly.

5. Repair

The JMEEP will require repair when damaged by use, disaster, flooding, earthquakes. PLGU commits to the ongoing repair of the construction on a monthly or quarterly basis.

6. Destruction

Upon the end of the construction (either from intentional or natural destruction) the PLGU commits to the careful dismantling of the park, so as not to compromise the integrity of the ecobricks. The ecobricks will then become the possession of the PLGU for use in other projects as it so chooses.

7. Ful Agreement and Arbitration

- a. The GEA and the PLGU both agree to the stipulations and commitments laid out in this document with regard to the construction, enhancement, maintenance, repair and destruction of the JMEEP. Herewith, representatives of the GEA and PLGU sign their consent and commitment.
- b. Should either the GEA or the PLGU fail to maintain their commitments as laid out in this document, both shall send representatives to an in person meeting at the JMEEP to resolve any issues. The GEA and the PLGU reserve the right to seek an outside party for arbitration. Should this occur, both the GEA and the PLGU must agree upon the third party arbiter before meeting.
